Resident's Tax Report 2018

from February 8th (Thur.) through March 15th (Thur.)

Please file a resident's tax report to the City Office related facilities by March 15th, 2018 on the income you earned during the previous year (2017).

Eligible person : Everyone who lives in the municipality as of January 1st, 2018 and has income for the previous year (2017).

* Note: However, those who are subject to the items below do not need to file a resident's tax report;

- ① if you are salaried employees of a company that submits a salary payment report to the City Office.
- ② if you are under 65 years old, and living with only the retirement income of which the upmost limit is 1,010,5000 yen a year. (For 65 years old and over, the upmost limit of the retirement income has to 1,515,000 yen a year.)
- ③ if you have filed an income tax report with the Kumagaya tax office.
- ④ if you didn't earn any income in 2017. (except you need an income certificate or you join the National Health Insurance system and the Care Insurance system.)
